





With David Crick in the Chair the Working Party consists of representatives from both the RA and the FA. With support from both organisations, one of the core offerings to the members will be for the FA to provide Tutors to lead high quality training at LRA meetings four times a year. These will become formal CPD events for Referees and may well underpin promotions and appointments.

QUEST

The audit team has recently awarded Thurrock with Silver QUEST, the third LRA to achieve this award and we hope they push toward Gold.

As an aid the RA-FA working group's aims it would be helpful if ALL LRA's aimed to achieve at least the Bronze Award, which is a relatively easy step, as every LRA has Rules/Accounts/Auditor, the basic objectives of support to the RA and the local members.

The R.A. Board is pleased to introduce our newly elected member. John Key registered as a referee in 1999 and is currently a Level 4 match official, mentor and recently qualified assessor. He has been Secretary of Barkston Ash R.A. since 2001. Having witnessed significant changes in his own LRA over recent years and seeing the positive impact this can have on people's lives his motivation to join The R.A. Board is to support other LRAs in moving forward and giving their members the support they need. He has been handed the responsibility for the R.A. QUEST scheme, liaising between the auditors and LRA's. QUEST has been a key factor in Barkston Ash's progress and he is extremely passionate about getting LRA's involved in this process.

R.A. Benevolent Fund

One of the benefits of membership of The Referees Association is having access to the Benevolent Fund. However the majority of members are probably not aware of what it is and how it can be used.

The Fund was originally started in the 1920s and was set up to give assistance to members who were in need of financial help. Over many years donations from individuals, societies and bodies have been made into the fund and it has been subject to good husbandry. As a result the Fund currently has assets well over £100000.

The purpose of the Fund is (quoted from the Trust Deed) "to provide

partial relief in times of hardship to full members of the Referees' Association and their dependents at the time that their hardship was identified and to former members or their dependents". Grants have been made for small sums such as £100 as well as larger amounts some in excess of £2000.00

L.R.A.'s and C.R.A.'s are requested to bear in mind the Fund when you become aware of members in need, even if it is only a temporary financial difficulty caused by illness, injury, unemployment or other misfortune. The Benevolent Fund is there to help such members and the Trustees will do all they can to assist them.

3 Year Plan - Executive Summary

The board agreed a 3 year business plan in January 2015.

The proposed Executive Summary of the 3 year plan 2015 to 2018 is the restructuring of the RA to ensure it becomes more relevant to Refereeing development, and offers **Something For Everyone.**

Background – The RA is 106 years old and a close study of its history shows nothing new, as the 1914 records show indifference from The RA to the Football Association (The FA). Many local associations refused to join the National Union of Referees with Bradford and other LRAs (Local Referees' Associations) in "industrial areas" feeling that The RA was not active in challenging The FA. History also shows Board difficulties in 1921 when it moved from being a union to The Association. More recently in the last 10 to 15 years The RA has suffered from a loss of focus with a bottom up strategy in which the County RAs (CRAs) and LRAs have become distanced from the national leadership. The net impact is an organisation which has three individual levels – Board, County, and Local with no overall strategy for recruiting referees or retaining members in The RA.

<u>Mission Statement</u> - "We provide outstanding support to all Referees, through continuous training, development and linked to social opportunities."

Organisation Vision - "To provide our members with the best possible experience from the beginning of their refereeing career through a support structure that ensures their match day experience is enjoyable safe and allows them to progress through The FA levels of refereeing. We believe in the deep collaboration with The FA which allows us to change as the game changes and ensures our core values are so embedded that we become the organisation of choice for all Referees"



- Appoint Independent Chairperson, re-model the board with 7 elected board members from the membership and 4 non-executives representing The FA, The PGMOL and RA-FA Youth Council plus one other from the football family.
- 2) Each County RA to be targeted with **75%** of the membership coming from active referees, and therefore a national target of 75% of the active refereeing workforce in membership.
- 3) Each County RA to raise the quality standard of Refereeing Development by enhancing all aspects of QUEST, with 50% of LRA's achieving Bronze award by December 2016 and 20% of LRA's achieving Gold by December 2018.
- 4) Every CRA and LRA to produce a marketing plan in conjunction with the CFA to achieve awareness and attendance.
- 5) To ensure the RA as a business is sustainable for the long term benefit of future members.
- 6) The value for money should not be under-stated 25p per week or £1 month, investment in training/development and support materials should be at the core of all activities target **50%** of turnover.
- 7) Strengthen the RA conference to becoming a nationally recognised CPD event.
- 8) Consolidation of LRA's for meeting experiences/events and pro-active support of local CPD events.
- 9) Locally and via the County structure to be a first choice organisation for refereeing development by protecting the reputation of the RA with holistic thinking of how the wider football family view the RA. (i.e.stakeholder interfaces/meeting locations/websites/marketing materials/visitors).
- 10) LRA's/County to embrace the 3 year plan to achieve a modern organisation for future generations or in 2018 AGM **implement clause 9** of the RA constitution.
